- 4. Christmas music **ONLY** should be played from each entry. **NO SANTAS ON FLOAT!!!**
- 5. **ALL** entries must be decorated.
- 6. The parade will start on West Front Street and end in the DOLLAR GENERAL parking lot in downtown. Roads behind the Civic Center will be closed! <u>Parents/guardians of children and individuals who were in an entry must come to this parking lot to pick up **NOT** the Civic Center.</u>
- 7. <u>Please have your entry on its designated color-coded street NO LATER THAN 8:45 A.M. Line-up order is FIRST COME FIRST SERVE. You may start lining up at 7:00a.m.</u>
- 8. A 18+ licensed driver must remain with your entry at **ALL** times.
- 9. Have ALL participants of your entry at its location NO LATER THAN 9:00A.M. No exceptions.
- 10. Must have a sign or banner with your group/business's name attached to BOTH sides of your float.
- 11. **DO NOT** block the street with your entry during line-up or the parade.
- 12. Minimum of FOUR walkers per float entry. 2 IN THE FRONT OF VEHICLE & 2 AT THE BACK OF THE FLOAT! MAXIMUM OF 6!
